PLEASE PRESENT THE ORIGINAL DOCUMENT AT THE COUNTER

Dear fellow citizen, Dear Company,

as already anticipated, for the next few weeks, in collaboration with G.eco, the collection of the undifferentiated dry fraction will be activated with a CONTAINER equipped with a microchip.

From November 2023

for not differentiable DRY WASTE, bags will be collected only inside the appropriate containers provided by the Municipal Administration.

OTHER WASTE FRACTION collections remain UNCHANGED.

All citizens have to organize to equip themselves with the assigned container.

To obtain it, with a smart instructions book, each user must reach the following site on the indicated timetable:

If you are unable to reach the delivering point on the above timetable, you can delegate another person by the DELEGATION section present at the end to this document.

For citizens residing in CONDOMINIUMS managed by an Administrator, contact him to define the new configuration of the conferring spaces. The new collection includes a bin for each TARI taxpayer, therefore each citizen will display his own bin.

Also, at the distribution desk it will be possible to request and collect the special bin for the provision of HEALTHCARE ASSISTANTS for children up to 3 years of age and for adults who use them regularly (diapers, catheters, hygienic underpads, ostomy bags).

For those entitled, it will be sufficient to complete and present a special self-declaration available in paper form at the counter or an electronic copy can be downloaded at the following address: www.comune.suisio.bg.it.

The new collection method, in addition to allowing for a more orderly and cleaner delivery, has as its objective a better differentiation of waste and greater fairness, as it will allow the Municipal Administration, once the experimental phase is over, to adopt a new calculation of the tariff, based on the actual number of emptyings of the containers of each individual user: the charge, in essence, will be proportionate to the actual production of unsorted waste.

The commitment of those who better differentiate their waste and those who undertake to produce less, also by changing their purchasing choices and consumption habits in order to achieve greater environmental sustainability, will be concretely recognised.
